## **RELEASE & WAIVER OF LIABILITY** **ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

The undersigned contracts and agrees as follows:

I HEREBY REQUEST AND RECEIVE:

1. Permission to enter onto the track, staging area, and pits.
2. Permission as driver or crew in racing events.
3. Permission to compete for money, prizes, recognition and/or awards.

IN CONSIDERATION of being permitted to participate in any way in the Drifting Competition during the 37<sup>th</sup> Annual APL Smokin' Wheels Weekend, I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of off-road /motor sports activities and that I am qualified, in good health, and in proper physical condition to participate in such activity. I further acknowledge that the activity will be conducted in a facilities open to the public during the activity and upon which the traveling are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the activity. I also acknowledge that I am not an agent, servant or employee or release, and no oral representation or inducements have been made to me to sign this agreement. **I am at least 18 years old or have a valid minor release form signed by my parents/guardian.**

2. FULLY UNDERSTAND that: (a) OFF-ROAD/MOTORSPORT ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASE" NAMED BELOW; (c) The consumption of Alcohol or use of drugs / controlled substance is not permitted while participating in the event. (d) There may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES EITHER NOT KNOWN TO ME OR NOT READILY FORSEEABLE AT THIS TIME; AND I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur or cause to the property or others as a result of my participation in the Activity.

I HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the organizers, Upshift Ent., Guam Racing Federation, Chamorro Land Trust Commission, event sponsors, their respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and leasers of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, I or anyone on my behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as a result of such claim.

**I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.**
